

GS1 US Data Hub 3.2 | **RELEASE NOTES**

EFFECTIVE: July 10, 2017

Data Hub 3.2 enables GS1 US subscribers to identify, create, manage, use, and verify data through one convenient, data-sharable platform. This release covers user requested changes and clarifications since the last update November 2016.

REQUIREMENTS

- **NEW EXPORT CENTER** allows Product and Location users to perform other requests during system processing. Available for all create/manage subscribers and view/use subscribers with the export subscription add on. Functional areas and requests that trigger output to the export center span Product and Location
- Location: Quarterly GLN Duplicate Report to be e-mailed to GPOs

ADDITIONS

- Home Screen: Hover text added on top right icons: **Read Message, Read Notification, Pending Approvals**
- Export confirmation pop-up, icon on home screen, notification and separate data table
- Product Additional Information for Variable Measure: Displays reminder message to enter measurement information as application identifiers when the barcode is generated.
- Product Additional Information: Help bubble is added to the photo field providing file type and size limit
- Product Manage In Use Product Detail: Green banner with [link](#) to list of GS1 US Certified Content Providers
- **NEW** Product Import Template Field Requirements and Error Message Documents
- Location drop down menu includes a Download for Location Administrators to access the full healthcare location listing
- Company View/Use: Separate file size, non-US and search warning messages introduced

CORRECTIONS

- Product Manage: Data Table column label changed to "Packaging Level" for Draft, In Use and For Reuse tabs
- Product Manage Reserved: Comma separator added to error and confirmation messages when reserving more than 999 GTINs
- Product Manage **and** Product View/Use: Export all Products from Table – Confirmation modal: "close" button changed to "cancel" indicating no records will be downloaded
- Location Create and Location Import: Refreshed country name and state/province list resulting from reported errors
- Location Create: For Top level GLNs, the Parent GLN field displays "Top Level Location (No Parent)"
- Location Manage **and** Location View/Use: Large Hierarchy message display modified
- Location Transfer message identifies unable to proceed when descendant record has pending changes
- Location View/Use: The 'Export' button is disabled for third party users who do not have the export subscription add on or for subscriptions that are inactive

CHANGES

- Administration: Location Settings "Company Internal Interval" revised to read "Inactive GLN Reuse Interval"
- Product dropdown menu: Import/Export now reads Import
- Product Import: file references modified from "Export All Available GTINs" and "Export Products for Import" to "Download All Available GTINs" and "Download Products for Update"
- Location Import: file reference modified from 'Export Locations for Import' to 'Download Locations for Update'
- Location View/Use Export Hierarchy descendants (children) and ancestors (parents) labels modified to add clarity
- Scheduled Reports: Report filenames and labels modified to add clarity and date stamp

REMOVALS

- REMINDER: Results files will be deleted from data tables after 90 days on Import and after 30 days on Export.
- Tab delimited export file format change: double quotes are removed from around field values
